#### Context Statement

Greenock Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 105. Greenock Primary School is classified as Category 6 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 1% Aboriginal students, 9% students with disabilities. ### **Governing Council Report**

Achievements of 2023 included:

- Involvement in the consultation process for the Principal's position at Greenock Primary School with the continued appointment of Gail Holland.
- Finalisation of the maintenance of the Wellbeing Room primarily undertaken in 2022, with official thanks by the Governing Council to corporate contributors.
- Production of the Greenock Primary School Year Book.
- Fundraising efforts in 2023 have focused upon increased engagement with the school and local community including;
  - Vintage Festival stall at Murray Street Vineyards.
  - Community BBQ on Referendum Day held at the Greenock Institute.
  - Morning tea canteen at Sports Day with engagement of the Greenock Cricket Club for a BBQ lunch.
  - Raffle and BBQ dinner at the End of Year Concert.
- Traditional fundraising activities have also continued including the Mother's Day stall and the Father's Day sock drive.
- Ongoing endorsement of the Friends of Greenock (FOG) Sub committee. Their achievements include regular
  Pancake Breakfasts for the students of Greenock Primary School, Morning/afternoon teas and the efficient running
  of the Second-hand Uniforms Pop-Up shop at timely opportunities like transition visits and Acquaintance Night.
- A Ground and Environment Working Bee was actioned mid year resulting in the painting of the Cubby House to seal for greater longevity, painting the stepping stones to increase colour in the junior primary area, increase natural light via the roof of the cubby and installation of musical wind chimes & bell.



## Performance Summary NAPLAN Proficiency


In 2023, the Australian Curriculum, Assessment and Reporting Authority (ACARA) - a Commonwealth Independent statutory authority - announced changes to NAPLAN performance reporting. This new way of reporting by ACARA that NAPLAN results from 2023 will not be comparable to previous years. The new approach replaces the previous numerical NAPLAN bands and the national minimum standard.







#### **Attendance Comment**

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
