Watervale Primary School is classified as Category 7 on the Department for Education Index of Educational Disadvantage. Governing Council Report

At the School Celebration, Governing Council shared school success throughout the year. Some of the highlights were that in 2024 Watervale won over \$11,000 in grant funding and completed projects from 2023's successful grants which have resulted in:

- o A food security grant to help us provide an important 'breakfast club' initiative
- o Self-regulation funding to support our student wellbeing needs
- o A third grant provided from Variety to support our end of year celebrations
- o Sporting schools funds to provide Taekwondo, Squash, Tennis and Volleyball training and equipment.
- Completed the chooks project, the woodworking shed and finished implementing the wellbeing grant won in 2023, continuing the Resilience Project pathway and them of Gratefulness, Empathy and Mindfulness.

Through the gaining of grant funding, savings in TRT expenses, and general 'thriftiness' - the annual school budget has returned a closing balance surplus of almost \$50k more than budgeted- a remarkable achievement which goes a long way to safeguarding the school against unexpected expenses, as well as being able to deliver future improvements and developments for the site.

Not only are school finances improving dramatically, but more importantly the growth in our children's literacy and numeracy.

DIBELS: Dynamic indicators of Basic Literacy Skills

- 38% of children reading AT year level at the beginning of the year to 30% of children at the end of the year.
- Moving from 4% of children reading ABOVE year level expectation at the beginning of the year to 17% of children at the end of the year

Brightpath Persuasive writing: Testing in Term 1 and again in Term 3

• 100% of children making growth

Brightpath Narrative writing: Tested in Term 2 and again in Term 4

- 92% of children making growth
- PAT-R 64% of learners from Year 3 to Year 6 made growth in their reading comprehension
- PAT-M 85% of learners from Year 3 to 6 made growth in their maths throughout 2024

Performance Summary NAPLAN Proficiency



Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
