# Context Statement

Brighton Secondary School caters for students from 7-12. At the time of this report, the enrolment in 2024 is 1677. Brighton Secondary School is classified as Category 6 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 3% Aboriginal students, 8% students with disabilities, 7% students with English as an additional language or dialect (EALD) funded background. # Governing Council Report

In 2024 Governing Council fulfilled its constitutional responsibilities, meeting twice each Term and completing its required approvals and confirmations.

After several years with major reforms taking place, 2024 was more of a consolidation year with widespread progress made across the school. The new House structure is well and truly embedded as shown by the enthusiasm and pride displayed by students and staff at House events throughout the year, and especially at the House awards ceremony.

The Special Interest Music program had an exceptional year, highlighted by outstanding results at Generations in Jazz, where nearly every ensemble achieved a top-three finish in their category. The annual Music Spectacular was another standout event, delivering a world-class performance and adding to the many occasions that showcased the remarkable talent of Brighton Secondary's music students throughout the year.

The school once again brought home the top national award for its volleyball program, reaffirming Brighton Secondary's position as the best volleyball school in the country. Year-level teams also delivered outstanding results across the national tournament in the Gold Coast.

This level of success is a testament to the students, teachers, coaching and instructional staff, and the parents involved in both programs. Council acknowledges and gives thanks for everyone's efforts and contributions, particularly the parent-driven support groups that do so much behind the scenes.

Academically and socially the school student community continued its positive direction. Several years of focused attention on wellbeing as an essential partner to academic endeavour is helping Brighton Secondary provide a balanced, welcoming, and supportive environment for all students.

As outgoing Chair I would like to acknowledge the contribution of the school leadership team to the constructive, collaborative, and well-informed relationship with Governing Council. It has been a pleasure and a privilege to work with the team in serving the school over the last 7 years.

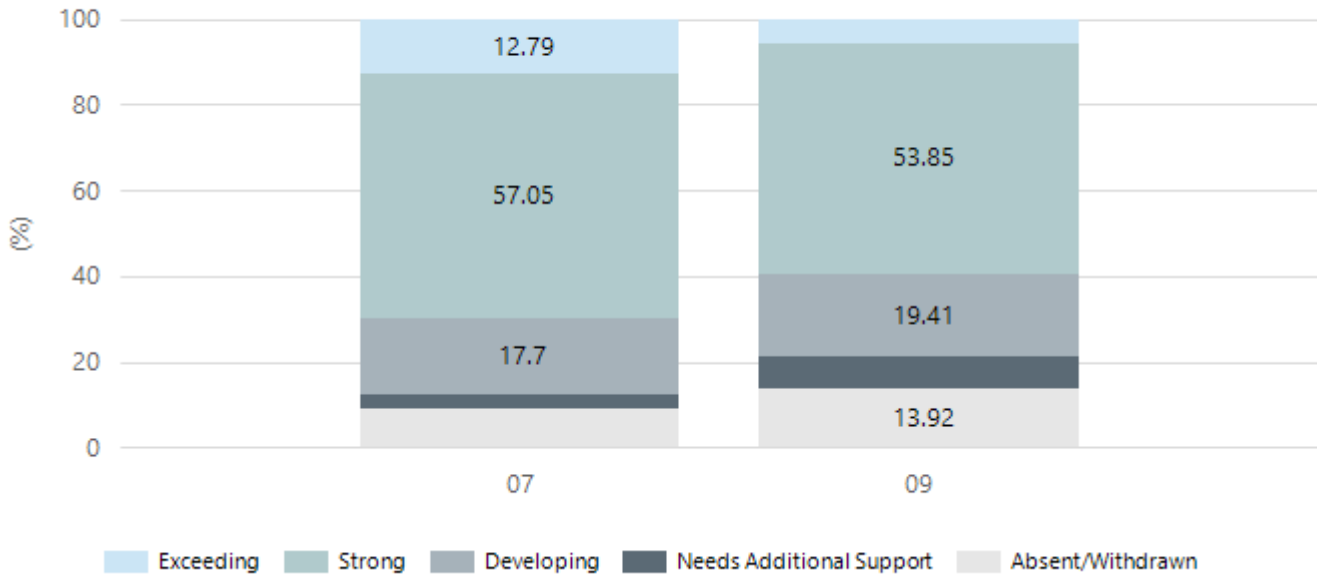

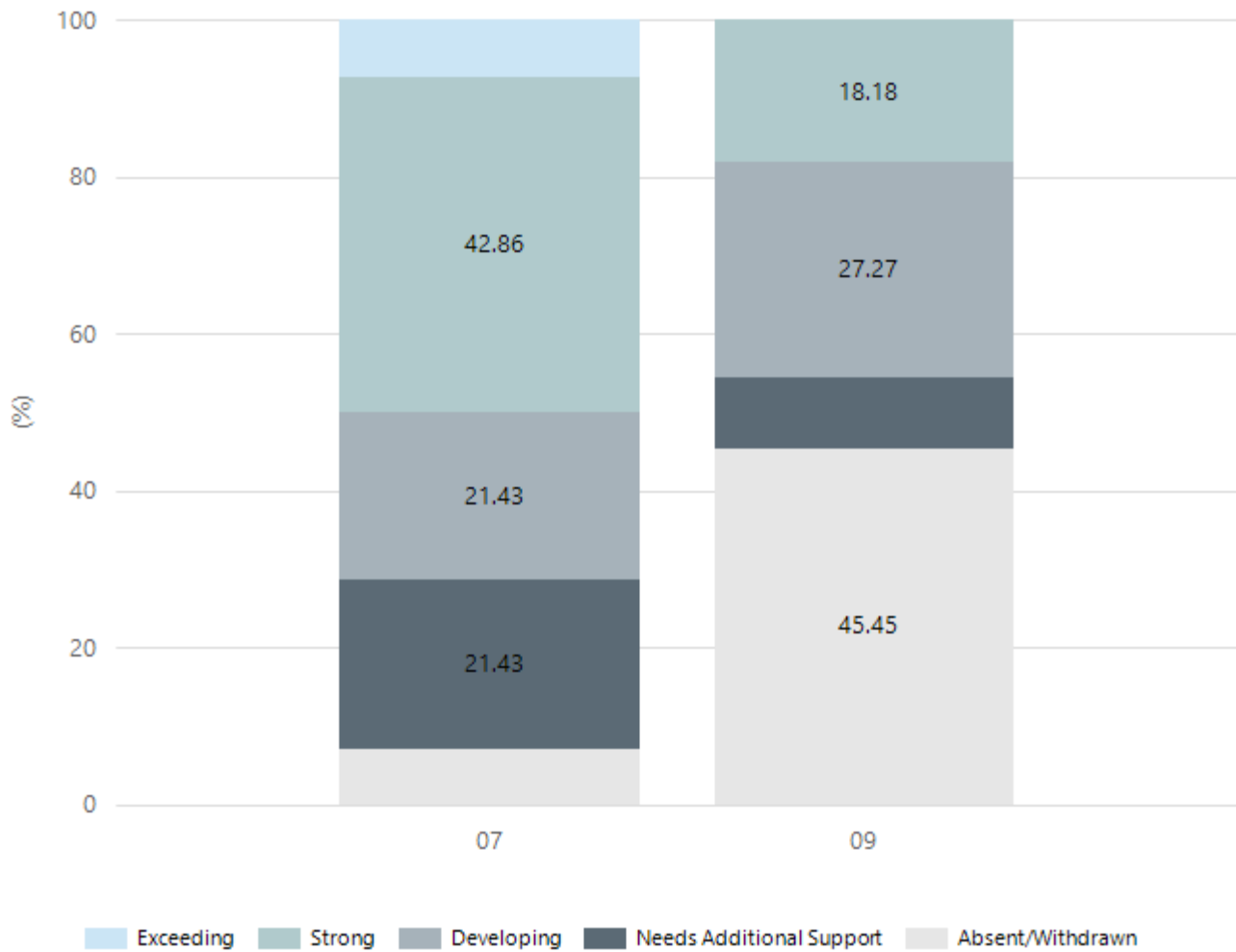

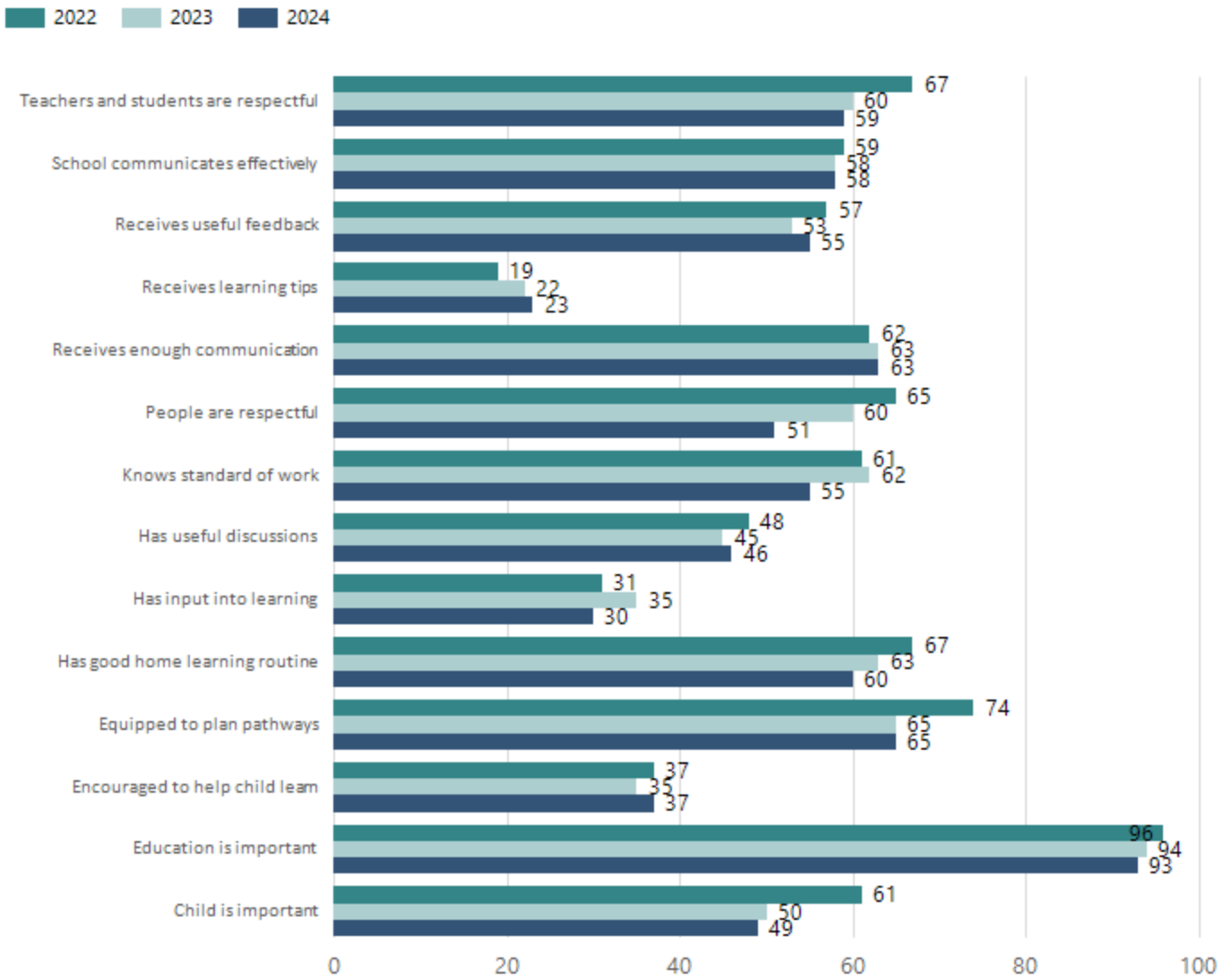

## Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
