Context Statement

Elizabeth Grove Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 235. Elizabeth Grove Primary School is classified as Category 1 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 17% Aboriginal students, 31% students with disabilities, 18% students with English as an additional language or dialect (EALD) funded background, 1% children/young people in care. Governing Council Report

The Governing Council identified the following as key achievements for 2023:

There was a significant contribution from the Governing Council in organising successful events across the school year, including Mothers and Father's Day Stall, Book Week Parade, Sports Day, Showcase Concert, Community Fun Day, and Christmas Raffle. We have been energised by the continued increase in community engagement across all aspects of the school. Parents have connected more with teachers using communication methods and have had a strong presence at our school events.

The OSHC was successfully managed by the Governing Council and continued to experience high enrolment numbers. The Governing Council also farewelled our OSHC Director to retirement and appointed a new Director to start in 2024.

The Governing Council have also overlooked the refurbishment of our library roof and supported our grant application to Way To Go which has provided us funds for a new bike/scooter enclosure, bike education and a new school crossing.


They also contributed to our successful External School Review Process in term 4.

Year One Phonics Screening Check


The phonics screening check (PSC) tells year 1 teachers how their students are progressing in phonics. This is a foundational reading skill.



Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course, or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school and attends school all day and everyday it is open unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
