
### **Context Statement**

# Performance Summary NAPLAN Proficiency


In 2023, the Australian Curriculum, Assessment and Reporting Authority (ACARA) - a Commonwealth Independent statutory authority - announced changes to NAPLAN performance reporting. This new way of reporting by ACARA that NAPLAN results from 2023 will not be comparable to previous years. The new approach replaces the previous numerical NAPLAN bands and the national minimum standard.







### **Attendance Comment**

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.

The Willunga High School Governing Council is a volunteer group of parents of Willunga High School students, teacher representatives, public officials and the school Leadership team who donate their time to attend meetings twice a term. Governing Council has roles in financial accountability, Canteen operations and in the overview of site and student improvement and growth, student and staff welfare, policy review, school branding and the community perception of the school and our students.

Some of the actions taken by Governing Council this year:

- Advocating for, and achieving, the installation of a "School Zone" speed limit in front of the school to greatly improve the safety for our students and families.
- Reviewing and endorsing policy changes including
- Enrolment and Admissions Policy
- Inclusion Policy
- Feedback, Assessment, Reporting and Monitoring Policy
- Languages Policy

In preparation for our accreditation assessment by a team from the International Baccalaureate Organisation for our endorsement as an International Baccalaureate Middle Year Program school.

- Ongoing review of school uniform continuing to seek student feedback for expanding the options available to students while still adhering to the recently reviewed uniform policy.
- Review and set Materials & Services charges for 2024
- Ongoing review and reflection of the improvement progress the school is making alongside the our alignment with the Strategy for Public Education in South Australia

Future activities of the Governing Council will reflect the ongoing challenges that result from changes in the school population due to the opening of the Aldinga school, ongoing advocacy for improvements in the school facilities and infrastructure and supporting the operations of the school to improve our students and families educational experiences.

The Governing Council is open to all parents of Willunga High School students and there is no requirement to hold an elected position. Parents, students and members of the community are invited to attend any meeting of the Governing Council and contribute to their school community.

I would like to thank all members of the 2023 Governing Council for their dedication to the role, for their support of the school leadership, staff and students of Willunga High School.

In 2024 the Governing Council will have important roles as the parent representatives with regards to the accreditation visit for the IBMYP and the ongoing advocacy to ensure our students are able to equitable access modern and safe learning environments.
