



#### **Attendance Comment**

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.

2024 Governing Council Report.

AEEC's 2024 Governing Council consisted of just enough new and experienced members to make up the required quorum. The Governing Council meet twice per term online via Microsoft Teams.

This year AEEC's personal development focus was on a whole school Sensory Profile. To support this focus AEEC engaged the DfE Self-Regulation team to up skill staff as a part of their Personal Development requirements. Feedback was positive and staff were eager and engaged in implementing the skills and knowledge gained from the self-Regulation Team from DfE. The term 2 wellbeing survey identified that Emotional Demands on staff were the most impactful to their wellbeing. A new public education strategy for 2025 was announced and would be focusing on 'whole school wellbeing'.

Due to the cancelled 2023 Operation Flinders exercise Claire fiercely and successfully advocated for AEEC to be allowed to engage in an exercise in 2024 which Claire, Baxter & 5 students attended. Feedback from both staff and students was that it was an amazing experience and whilst not all students (of course this was my child Tom!) said they enjoyed it for some time after their return that opinion was shifted to one of it being a positive opportunity. This opportunity also gave our students a rare chance to engage with a main stream media production and an well-known journalist as they were interviewed for channel 9's 60 minutes segment about Operation Flinders.

Thanks to Grants & donations received from several Rotary Clubs AEEC was able to create a new sensory room with some wonderful equipment installed which was completed and ready for use in Term 2. Several other projects AEEC have undertaken this year was the Basketball Court resurfacing and the creation of a Café kitchen garden. The students were also invited to join the Ladies of Variety event throughout the year with positive feedback on the events attended.

2024 saw a record number of students graduate. A total of 16 graduating students transitioned away from High school, with 5 students transitioning on to further education opportunities. Have so many students graduate left the student numbers for 2025 down significantly. To recruit new students for 2025 AEEC held open mornings which successfully attracted 7 new enrolments for 2025. These open mornings provided some great positive feedback from those who attended.

At the end of 2024 AEEC said goodbye to 3 of our amazing teachers, with one retiring and the other two moving forward with their careers in other sites and settings. All will be sadly missed. 2024 will also see one staff member take a 12mth unpaid sabbatical for 2025. These changes in staffing required replacement staff be found and hired, whilst also allowing a change in the number of classes and which teachers could be used to fill the spots not only in the class as a teacher but SACE co-ordinator, transition co-ordinator & curriculum.

The safety of the school crossing closest to our site was raised at one of our meetings. It was agreed that we contact Charles Campbell College's Principal and Governing Council with the concerns raised and propose that working together in the interests of ALL students using the

crossing's safety we take these concerns to our local council with the hope an outcome of improving student & parents safety can be worked towards. This will be an on-going issue that the members of Govern Council who intended to volunteer again next year would carry over and continue to investigate.

Finally I would like to thank all of the members of the 2024 Governing Council for their participation and support for AEEC and its staff. We said good bye to Ian and Laura as their children graduated and moved on to their next journey. Thanks to Michele & Maree and I look forward to Governing with you and others in 2025.
