Amata Anangu School caters for students from R-12. At the time of this report, the enrolment in 2024 is 110. Amata Anangu School is classified as Category 1 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 100% Aboriginal students, 3% students with disabilities, 3% children/young people in care. # **Governing Council Report**


In 2024, the Governing Council of Amata Anangu School focused on strengthening our connection with the community and broadening representation within the council. These efforts have ensured that more voices are heard in decision-making, reinforcing our commitment to work together to support students, families, and staff. A significant highlight of the year was our participation in the Ernabella Dance competition in Term 3. This event was embraced by students, staff, and community members, demonstrating a strong sense of pride and engagement. Amata Anangu School placed third in the competition, thanks to the dedication and enthusiasm of our students.

Another key achievement was our increased participation in NAPLAN testing, providing us with valuable data to track student progress and inform teaching strategies. This commitment to academic growth aligns with our broader goal of improving educational outcomes. Towards the end of the year, the school celebrated high attendance rates with a special attendance trip to the Gold Coast. Eighteen students who consistently demonstrated strong attendance were rewarded with this experience, reinforcing the importance of regular school participation. This initiative highlights the school's ongoing commitment to foster a positive learning culture and recognise the strengths of our ninti Anangu children. The Governing Council looks forward to building on these successes in the coming year, continuing to work in partnership with the school and community to support student learning and wellbeing.

# Performance Summary NAPLAN Proficiency




# **Attendance Comment**

In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020. Due to some technical difficulties with online attendance reporting the attendance figures for year 2 to year 7 do not reflect accurate attendance data.
