Context Statement

Para Hills West Primary School caters for students from R-6. At the time of this report, the enrolment in 2024 is 270. Para Hills West Primary School is classified as Category 3 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 6% Aboriginal students, 17% students with disabilities, 16% students with English as an additional language or dialect (EALD) funded background. Governing Council Report

In my second year, I am honoured to have held the role of chairperson of the Para Hills West Primary School Governing Council. Most of our council has carried on from 2023 with the addition of a few new members to make up our team.

The Governing Council of our school is an important body made up of friends, parents, teachers and the leadership team of the school. It is responsible for the major decision making of how our school is run and to work through our policies and procedures to make for a smooth-running school.

2024 has been an exciting year as always with our usual events such as Sports Day, Concert, Book Week, Footsteps Dance, Wakakirri, Children's University, Festival of Music Choir as well as stalls for Mother's Day and Father's Day. The year 4,5,6 students attended a camp at Arbury Park which was a fabulous success and great to see students develop their skills in an environmental camp over three days. PHWPS also participated in SAPSASA events including Netball, Football and Tag Rugby to name a few.

During 2024, the School Improvement Plan continued the focus on improving student achievement and outcomes in both Reading and Mathematics. The staff have been engaged in professional learning in developing an effective structure in mathematics where daily Maths Chats are an integral part of the student's learning. The shift from Running records to DIBELS ORF and Maze was also being trialled by staff. The school has also begun to work with the Department for Education's New Strategy – Children and Student's Learning and Thriving. This is an exciting time for the Governing Council as they will explore this Strategy further in 2025.

The IELC continued to grow with the creation of 5 classes and saw the number students increase rapidly from 45 students to 70 by the end of the year. This is a wonderful opportunity for our school to add another dimension to our school community and embracing the rich cultures from across the world.

This year our school canteen remained open for two days per week, thanks to Anita Ryall. She has volunteered in our canteen for the past 3 years and it is sad to say that she will no longer be able to continue in 2025. We are currently seeking other parent volunteers to take over and help keep our canteen open as a service to our school community. On behalf of the Governing Council, I would like to thank Anita for the wonderful work and commitment she has given our school.




Performance Summary NAPLAN Proficiency





Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
