Context Statement

Noarlunga Downs Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 98. Noarlunga Downs Primary School is classified as Category 2 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 26% Aboriginal students, 28% students with disabilities, 6% students with English as an additional language or dialect (EALD) funded background, 5% children/young people in care. Governing Council Report

We would like to thank the parents, and staff of the 2023 Noarlunga Downs Primary School Governing Council for their time and contribution throughout the year.

The governing council resumed face to face meetings in 2023 and this appeared to work for most meetings however a hybrid of face to face and online will be discussed for the 2024 year to accommodate everyone's needs and ensure that we can allow everyone a voice.

Several topics have been discussed and numerous decisions ratified. The major topic for discussion was our OSHC situation and how to ensure a service is provided at the school to ensure ongoing enrolments.

The governing council engaged in celebrating the school's 35th year and the events were well attended by the community. We have a small cohort of dedicated governing council members however attracting new members to the roles has presented us with a difficulty and will need to be a focus of further discussion in 2024.


Fundraising is something we continue to have on hold due to the financial pressure that families are experiencing at present.

NAPLAN Proficiency





Attendance Comment

In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.


Proportion of agree/strongly agree responses (%)


Proportion of agree/strongly agree responses (%)

Proportion of agree/strongly agree responses (%)




