#### **Context Statement**

Miltaburra Area School caters for students from R-12. At the time of this report, the enrolment in 2024 is 55. Miltaburra Area School is classified as Category 6 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 11% Aboriginal students, 7% students with disabilities. ## **Governing Council Report**

We headed into 2024 with unusual weather for the farmers and their cropping season, experiencing well below average rainfall in most areas across the Eyre Peninsula and South Australia as a whole. Our oyster growers also had unfavourable conditions, with the ocean producing a cold upwelling, which would normally bring an abundance of food for the bays, but this failed to reach the Far West Coast region of Smoky Bay and Denial Bay, making for a tough year for all families.

However, we are a resilient community, which is why it is fantastic and timely that the school has implemented the Resilience Project this year. Many thanks to Rebecca Hammat who passionately oversees this project and is dedicated to ensuring a focus on Gratitude and Empathy, and how our children can implement this into everyday life thus making healthier and more positive choices.

Our Sports Day was hosted by Karcultaby in February, with combined Miltaburra and Karcultaby school students competing. It was a hot day, but all ran smoothly, with Nunulla winning the day with 483, and Lamuckla close behind on 472.

Term 2 saw the students perform in the Music concert at the Wirrulla Hall, which also included a Quiz & Auction night. By all accounts it was a very successful event, raising funds, which helped go toward the secondary school camp to the snow. The students also raised funds through other activities.

Spriggy, an Online payment platform was implemented into our parent run canteen this year, streamlining the ordering process for canteen volunteers, parents and Sondra. There has been a great response to this.

- Bus routes; proposed routes were shown to the parents
- Newly designed uniform for sports days
- Canteen Prices/options
- House next to the school was put on the market for sale
- School uniform options
- The government is moving towards 3-year-old preschool in 2026
- Continuing the Resilience Project
- Continuation of curriculum mornings, eg Ag Assembly


We have no SACE results to report as there were no year 12 students during 2024.

Attendance continues to be a focus area, having regard to the impact of context and the challenges of geographic remoteness.


# **NAPLAN Proficiency**




#### **Attendance Comment**

In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
