Context Statement


Flinders View Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 133. Flinders View Primary School is classified as Category 1 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 74% Aboriginal students, 8% students with disabilities, 47% students with English as an additional language or dialect (EALD) funded background, 2% children/young people in care. Performance Summary NAPLAN Proficiency





Attendance Comment


In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.


Proportion of agree/strongly agree responses (%)


Proportion of agree/strongly agree responses (%)

Relationships and Communication


Proportion of agree/strongly agree responses (%)

Leadership and Decision Making


Proportion of agree/strongly agree responses (%)

Governing Council General items

Due to Constitutional changes, a small reduction in the number of voting members was implemented. It has also been established it is now compulsory for all Governing Council members to have current WWCC (Working with Children Checks).

The Education Department provided Governing Council training for any members interested. This training provided plenty of resources and information for members through the Department website.

Our Governing Council applied for a Pastoral Care Worker position and received funding for the next 3 years.

A grant application was also approved for a Parents in Education Grant. This incentive will be run in 2024.

Governing Council members also approved funding for the car lease and shed to house the vehicle securely. Other approvals included the replacement of the sound field system, flooring replacement in admin building, new interactive whiteboards in all classrooms, and extra funding was approved to complete Bush Tucker Garden.

Surveys were completed by staff, students, and families to consider ideas to change and/or include other clothing items to the school uniform. A small price increase to the school uniforms was also required due to inflation.

Rowan Ramsey Award

The Rowan Ramsey Award was awarded to Ange McAuliffe for her ongoing work as Wellbeing Leader in supporting students and families at school and in the community.

Pre-School

Unfortunately, terms 1 and 2 were off to a shaky start due to staff shortages. This not only impacted on the students and families, but also highlighted inconsistencies in the National Quality Standards Assessment resulting in only 6/7 outcomes met by the preschool. This also created an Amendment of Service within the department had called for a reduction in student numbers and the Preschools operational hours, there for changing the days from Mondays to Thursdays.

During 2023, other changes within the Education Department resulted in the preschool building area being reduced. The wet area attached to the preschool and reception classes is no long considered part of the preschool. Risk assessments are now to be completed to use this area.

FVPS Play Group continues to thrive and support our up-and-coming Preschool children and families held every Friday. Creating a familiar environment for their transition into Preschool.
