After attending Tanunda Kindergarten back in 1986, it was a huge honour to have fulfilled the role of Chairperson of the Governing Council in 2024. As I look back on 2024, I want to express my sincere gratitude and appreciation to our Governing Council members Elle, Grace, Mel, Fiona, Laura, Channy and Sammi for their passion and drive throughout 2024. I'd also like to express my appreciation to our teaching staff - Mel, Kim, Di and Janice – along with relief teachers, who contributed to the children's learning and ensured their progression into school was seamless.

#### 2024 had many highlights at the Tanunda Kindergarten:

**Appointment of Director:** A big congratulations to Mel Sinkinson, who began her journey at Tanunda Kindy as acting director in Term 1 and went on to secure a five-year term as the kindy's director. We wish Mel all the best in her new role and extend our heartfelt wishes to Mel and her family as they await the arrival of their baby.

**Fundraising:** The Governing Council were instrumental in organising a variety of successful fundraisers, including the Barossa Farmer's Market Community Breakfast, Easter Hot Cross Buns, two Lucky Square Competitions, Barossa Nursery BBQ, Amanti Pizza fundraiser, a Christmas Raffle and Picture Plates. Thanks to these efforts, an impressive total was raised. The Governing Council voted to allocate all funds towards further improvements to the kindy in 2025, with staff to make decisions on how to best use the money.

**Mid-Year Intake:** In Term 3, we were delighted to embrace new families into our Kindy as part of the mid-year intake. This created a wonderful environment as existing children welcomed new friends, sharing their experiences they've gathered in Terms 1 and 2.

**Upgrades:** Early in Term 4, the Governing Council approved the expenditure of some previous years grant money to be put towards safety measures in the playground and significant aesthetic improvements for the outside the Kindy building.

**Grants:** Several grants were applied for and secured in 2024 including the Casella 'Book Hugs' grant valued at \$8000 and also \$150 from the Coop Barossa. In 2025, grants that we know are available for application include Coles, Coop, and Planet Ark. Casella can be applied for every second year.

**Fruit Donations:** A big thank you to Governing Council members Grace and Sammi who, through their tireless efforts, secured fruit donations on a weekly basis to ensure free fruit could be provided to our children each day, which proved to be hugely successful.

In closing, I wish the Governing Council continued success in 2025 and we strive to make the Tanunda Kindergarten a wonderful place for our children, their families and our community.



All children are entitled to access a preschool program over 4 terms the year before they start school.



#### Governance, Leadership and Management





#### Quality of Teaching and Learning




