Governing Council Report

2024 was another busy and productive year for Preschool.

Facilities were upgraded and paid for by the site including:

· The carpark and front fence

· The front garden

· Basins in the kangas/kindy bathroom

• More efficient storage in the Directors office and Business managers office with new cupboards installed

In June the commencement of a meeting room extension and outdoor toilets project began

The Preschool children were able to access bush and beach kindy sessions throughout the year. Sign language, phonological awareness, protective behaviours and zones of regulation all formed part of the program being offered. The Island song became a popular group time activity and the children presented their acknowledgment to country and Island home song at the Island World's forum that KICE were hosting. The Aboriginal people in the audience were extremely moved.

Mid- year intake and exit for the Preschool children, ran smoothly with both the teachers and children adapting well to the change. Many parents attended their child's preschool enrolment meetings.

Educator's day was celebrated in September, with our amazing Educators being acknowledged. It was financially supported by Governing Council.

Preschool was assessed and rated by the Education and Standards board and received a successful "Meeting" in all 7 quality areas. This was achieved through the hard work and commitment of Educators and management.

Kingscote show provided a fundraising opportunity in the form of show bags which always proves to be popular. The Christmas tree festival was held in conjunction with Advance Kingscote and was again a great community event. The end of year Christmas party and craft night was well attended by families, with years of service being acknowledged for staff.

All of this wouldn't have been possible without the dedication shown by the KICS team. I also thank the members of Governing Council for their support. I have learnt so much about the operations of the Preschool during my time as Chairperson, but will be stepping down as my daughter is now at school. I encourage other parents to become involved and support the service.
